## **Doctoral Seminar "The global dimension in history and historiography", 17-18 September 2014**

The Association of Continental American and Caribbean Studies and Culture (KonaK Vienna) is happy to announce the doctoral seminar "The global dimension in history and historiography" to be hosted by the Faculty of Historical and Cultural Studies at the University of Vienna, directed by Wolfgang Schmale (University of Vienna) and Christian Cwik (University of the West Indies at St. Augustine). The seminar will take place at the University of Vienna from September 17 until September 18 as part of the international bicentenary conference "The Congress of Vienna and its global dimension" (18-22 September 2014, University of Vienna, <u>http://www.congresodeviena.at</u>).

The doctoral seminar deals with questions relating to the global dimension of historical events, phenomena, structures, and processes and their consideration for scientific analysis, interpretation and text production. It addresses advantages, disadvantages, possibilities, impossibilities, theories, methods, as well as potential results and perspectives, and suggests a structured cooperation between regional experts. The emphasis will be on the role of the Congress of Vienna as a turning point for different parts of the global community with regard to the rise of imperialism since 1815, understood as a product of "global thinking".

The seminar will provide a forum for doctoral students to present their work and receive critical feedback from experts as well as to discuss questions and problems with peers. This shall lead to an interdisciplinary and intercultural "polylogue". Presentations will be augmented with keynote addresses and parallel workshops dealing with a specific set of problems or reconsidering methodical approaches. The main goal of the seminar is to foster excellence in global history research by giving doctoral students constructive feedback and technical advice from senior researchers as well as the opportunity to exchange ideas with peers outside of their home institution and insights relative to career development. To create an easy atmosphere, we have scheduled social activities such as an informal get-together on the evening before the seminar and an excursion on the afternoon of September 18 exploring "Global places in Vienna". We encourage participants to stay for the duration of the international bicentenary conference.

Participants may focus on any area or field pertaining to the 18<sup>th</sup>/19<sup>th</sup>/20<sup>th</sup> century but should have a strong interest in building a global dimension into their work. We invite applications from doctoral students from any university in any country at any stage of their doctoral studies, and plan to have about 30 attendees. We are not able to accommodate the oral presentations of all the participants and will therefore make a selection. All others will be offered the possibility of presenting a poster. This will probably provide the option of displaying your poster throughout the main conference. However, keep in mind when applying that you must submit your paper or poster in advance, no later than 4 August 2014.

Application due date: 9 July 2014. Final decisions will be announced by mid July.

- 1) Cover letter (containing applicant's name, affiliation, email address, indicating your stage of research, and explaining your interest in participating in the seminar, 1 page)
- 2) Dissertation proposal (max. 5 pages)
- 3) Letter of support from your supervisor
- 4) Short CV (max. 3 pages)

Please include applicant's surname as part of file name for each document submitted.
